APRIL TOWN BOARD MEETING

During **public input**, discussion was had about the numerous commercial vehicles parked along Main Street. The board will look into creating a commercial parking ordinance in an effort to alleviate some of the parking issues.

The **Clerk's report** was reviewed with Kurt making a motion to approve. Rick seconded and the motion carried. In other correspondence:

- 2023 Board of Review will be opened prior to the regular May meeting and will adjourn until September.
- A Board of Review training will be held in Monroe on May 3 from 1-3pm. Amy, Kurt, and Doug will attend.
- It was decided to order and install a new door on the east side of the community center.
- Kurt will make two new covers for the air conditioning units at the community center to use during the winter.

The **Treasurer's report** was reviewed, noting cash on hand as of March 31 at \$357,190.13. Rick made a motion and Kurt seconded to accept the report. Motion carried.

There was nothing to report for the **planning commission**.

For **road maintenance**, board members discussed the list of roads within the township that need to be repaired this year. The board discussed a bid from Scott Construction and a bid from the Green County Highway Dept. but will make final decisions on road work at the May meeting.

• Doug will draw up an ATV/UTV ordinance, review it with an attorney, and present it at the May meeting for discussion.

The **bills** were circulated through board members. Kurt made a motion and Rick seconded to **approve payment of bills**. Motion carried.
